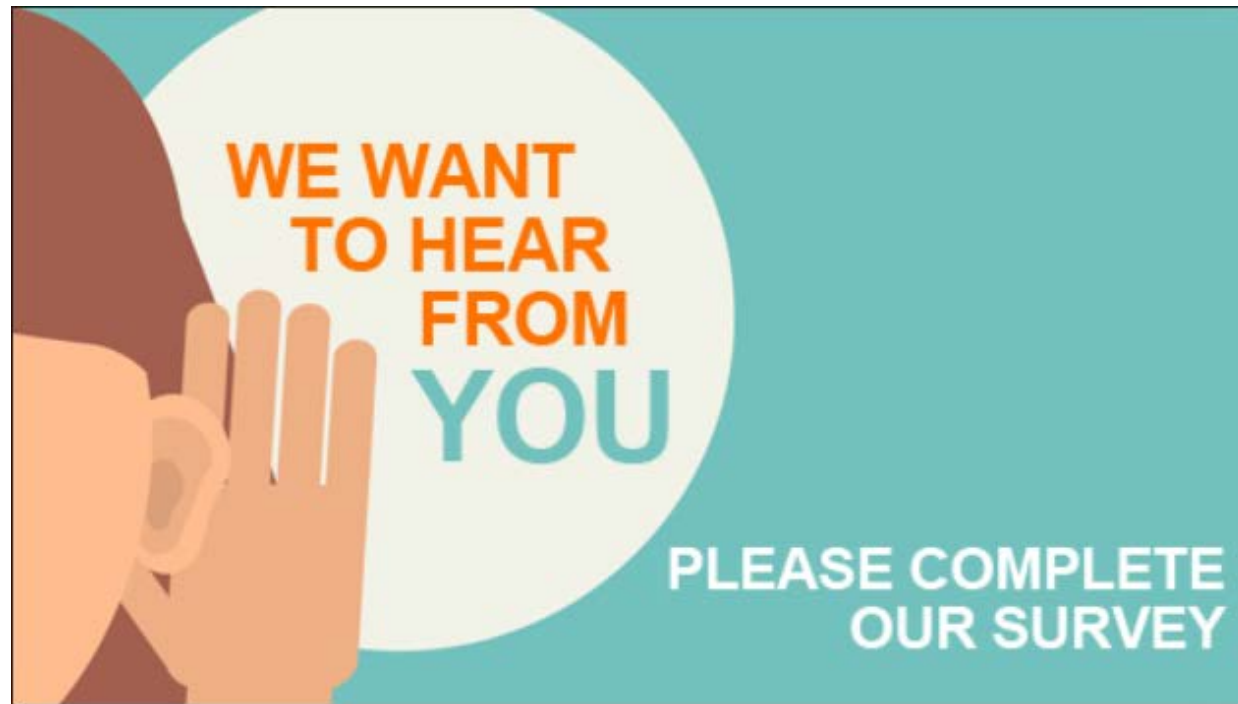

Participant Support Costs

Costs for individuals participating in research and sponsored programs may be allowable charges to an award.

Incentives for participating in human subject research studies are more commonly referred to as **study subject payments** or **research participant incentives** and are costs (cash or in-kind, e.g., gift cards) related to participating in research or other sponsored activities. For NSF proposals, Incentives are considered Other Direct Costs on the NSF budget form.

Participant support costs include stipends, allowances and fees paid on behalf of or directly to an individual participating in sponsored training or conference programs. NSF REU student stipends are considered Participant Support Costs and should be included on that line item in the NSF budget.

MTDC and F&A: Study subject payments are included in the proposal budget modified total direct costs base; participant support costs are *excluded* from the base and, accordingly, no F&A is charged on those participant support costs. NSF requires that Participant Support Costs remain segregated. Accounts Payable has a special DPAY form for payments and Research Finance uses the following **Banner subcodes**:

- 78010 Student Subject Payments/Incentives
- 74600 Participant Support Costs – Stipends
- 74601 Participant Support Costs – Other

• ePAWS

- New Deadline Date validation
 - ePaws will validate that Deadline Date is in the future...will produce a warning if date is in the past
 - Not an error – routing can continue after acknowledgement
- Added indicator to the search results showing submitted to sponsor date

• ePAWS 2.0

- Discovery Phase underway
 - Background review (off-site)
 - 2 week on-site requirements gathering (beginning of March 2018)
 - Phase I Proposal/Estimation of Costs/T&M Contract

FDP Expanded Clearinghouse

Welcome to the FDP Expanded Clearinghouse online system. This public website and user system are the products of an [FDP Pilot Project](#) to test the efficacy and efficiency of using online organization Profiles in lieu of subrecipient commitment forms to obtain information needed by pass-through entities when they are issuing subawards or monitoring their subrecipient entities.

What information is available in the organization Profiles?

Data included on each published organization profile has been certified correct by an applicable institutional official and includes data about the entity's most recent Single Audit, F&A, and fringe benefit rates as well as suspension and debarment, PHS financial conflict of interest policy status, Federal Wide Assurance number, other compliance-related information, and a wide variety of federal codes (DUNS, EIN, CAGE, etc.) and contact information (senior authorized official, FFATA, financial, COI, etc.) that are commonly needed for various types of subawards. All published profiles can be accessed by clicking on "Participating Organizations" above and are publically available without logging into the system. The FDP Pilot team monitors the Profiles regularly to ensure the data is current. The accuracy of the Profile information is the responsibility of the Pilot organization.

FDP Expanded Clearinghouse

- Federal Demonstration Partnership is a collaboration of 119 colleges, universities and academic medical centers in partnership with 8 federal agencies
- The goal is to reduce administrative burden
- As part of that the FDP has put together an Expanded Clearinghouse to help institutions reduce the number of *Subrecipient Commitment/Profile Forms* that need to be provided at the proposal stage
- It is not mandated that you use this clearinghouse, but you are welcome to let the other party know that we are part of the Clearinghouse and see if you can use that in lieu of completing the form
