# NU-RES Admin Updates

- NSF Fillable format files for C&P/Biosketch will no longer be permitted in 2023...must use SciENCv
  - DRAFT NSF 23-1 PAPPG:

## (a) Senior Personnel

This section of the proposal is used to assess how well qualified the individual, team, or organization is to conduct the proposed activities.

A separate biographical sketch (limited to three pages) must be provided for each individual designated as senior personnel through use of SciENCv - Science Experts Network Curriculum Vitae. SciENCv will produce an NSF-compliant PDF version of the biographical sketch. Senior personnel must prepare, save, certify, and submit these documents as part of their proposal via Research.gov or Grants.gov. (See Exhibit II-3 for

**Commented [NSF14]:** A new footnote has been added to reference the NSPM-33 Implementation Guidance section on "Disclosure Requirements and Standardization," as well as Table 2a on "Guidance for disclosure of personal and professional information within R&D award application processes," which provides more information on required disclosures.

**Commented [NSF15]:** Content has been revised to require use of SciENCv to prepare the Biographical Sketch. Use of the NSF Fillable Format will no longer be permitted.

## (ii) Current and Pending Support

(a) This section of the proposal is used to assess the capacity of the individual to carry out the research as proposed, as well as to help assess any potential overlap/duplication with the proposal being submitted.

(b) Current and pending support information must be provided separately for each individual designated as senior personnel through use of SciENCv. SciENCv will produce an NSF-compliant PDF version of the Current and Pending Support Section of the proposal. There is no page limitation for this section of the proposal. Senior personnel must prepare, save, certify, and submit these documents as part of their proposal via Research.gov or Grants.gov. (See Exhibit II-3 for the definitions of Senior Personnel.)

- NIH will also be aligning with SciENCv and ORCID in support of requirements from the Office of Science and Technology Policy (OSTP) NSPM-33 guidance for federal agencies
  - ORCID is currently the only Digital Persistent Identifier (DPI) that meets the requirements listed in the OSTP guidance
  - SciENCv, Research.gov, and Orcid- topics at the NU-RES June 2022 Boston Conference...

- Final reports that require NU-RES signature need to be routed to NU-RES ahead of the deadline!

Notice of Fiscal Policies in Effect for FY 2022:

**Ruth L. Kirschstein National Research Service Awards (NRSA):** NIH will increase NRSA stipends by approximately 2% for predocs and 2% for postdocs. The full range of stipend adjustments for FY 2022 is described in NIH Guide Notice [NOT-OD-22-108](#).

**Salary Limits:** Restricts the amount of direct salary to [Executive Level II](#) of the Federal Executive pay scale. Effective January 2, 2022, the salary limitation for Executive Level II is \$203,700. Further information is described in NIH Guide Notice [NOT-OD-22-076](#).

# System Updates

---

## NSF – Research.gov - Fastlane

- NSF will require the use of Research.gov for the preparation and submission of proposals in response to program descriptions after 12/31/22
  - FastLane will be removed from all program descriptions as a proposal preparation and submission option by December 31, 2022;
  - **FastLane is targeted to be removed as a submission option from all funding opportunities by December 31, 2022.**
  - Grants.gov will remain a submission option for most NSF proposals.
- Nearly all FastLane proposal preparation and submission capabilities are now available in Research.gov. For details about the remaining proposal features that will soon be added to Research.gov, please see the [Proposal Submission Capabilities](#)
