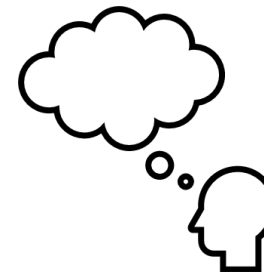
Data/Systems Updates

- EPAWs records not completed/proposal already submitted to sponsor
 - Between 7/1/22 and 11/30/22, there are ~115 proposals submitted but not yet completed
 - FY22 still has ~17 records still routing/already submitted to sponsor
 - Records not completed affects Deans ability to do projections, as the data is NOT in the Data Warehouse
 - Records not in the Data Warehouse reflects in the year over year numbers, which are trending down at this point

Total Funding Requested FY23 to date vs. FY22

	FY2022	FY2023	Difference	Difference %
Q1	\$293,658,764	\$248,694,441	(\$44,964,323)	15.3% ▼
Q2	\$240,718,828	\$151,149,237	(\$89,569,591)	37.2% ▼
Grand Total	\$534,377,592	\$399,843,678	(\$134,533,914)	25.2% ▼
